It is hereby notified to the Parents of the provisionally shortlisted candidates for admission into class-I **(Phase-2) as per the list uploaded on Vidyalaya Website on 09/04/2018** failing which the claim for the seat will be forfeited & further no claim for the seat will be entertained, subject to verification of original documents as filled at the time of **Online Registration** for the session-2018-19 that they should bring all the Original documents for verification. ***If during verification any document found to be incorrect/false then the provisional selection for admission in class-I under that category will be cancelled.*** They may admit their children on **10/04/2018 & 11/04/2018** between 11.00 AM to 2 PM as per the schedule mentioned below:

They are further requested to come with the provisionally selected candidates at the time of admission. The following documents are to be submitted in original along with self-attested copies. Original documents may be retained and returned after due verification.

1. Hard Copy (Print Out) of the **Online Application Form**
2. Birth Certificate showing date of birth, name of the Parents and the child
3. Proof of Residence (Any proof issued by the government/government agency in the name of the parent of the child)
4. Self-declaration about the distance of the residence from KV Boudh (The format may be downloaded from the Vidyalaya Website)
5. **Three** passport size photograph.
6. SC/ST Certificate issued by the competent authority (Certificate in the name of the parent may be accepted) – If it is in the name of the parent an undertaking should be submitted to produce the certificate in the name of the child within **03 months** from the date of admission (The undertaking format may be downloaded from the Vidyalaya Website)
7. Latest OBC(Non-Creamy Layer) Certificate issued by the competent authority – should not be older than one year i.e. it should be issued on or after 01.04.2017 (It should be in the name of the child for whom admission is sought, certificate in the name of the parent will not be accepted) – SEBC Certificate will not be accepted in lieu of OBC Certificate
8. Those claiming admission under EWS should submit valid **income certificate** issued by the competent authority (It should not be older than one year and it should be issued in the name of the parent of the child only)
9. BPL Card (Should be in the name of the parent of the child only) – Ration Card, NFSA Card will not be accepted in lieu of BPL Card.
10. Valid Disability Certificate issued by the competent authority – for the candidates selected for admission under Differently Abled category.

11. Service Certificate mentioning the number of transfers during the preceding 7 years issued by the competent authority & Certificate from the DDO/Head of the Office showing the Pay particulars of the employee(Applicable for Government employees only) – should be in the prescribed format available in the Vidyalaya website.
 12. For Government employees – ID card issued by the employer/last month's pay slip duly signed and sealed by DDO./front page of the service book duly signed by the head of the office
 13. For Ex-Service Man – Transfer details counter signed by the Zilla Sainik Board or by the competent authority (**Format available in the Vidyalaya Website**) , copy of the ID proof of ex-Service man and the pension book.
 14. Copy of Transfer Orders
 15. For Single Girl Child – Latest affidavit sworn before the **First Class Magistrate**.
 16. Any other documents as required by the admission committee as per the demand of the situation
- NOTE: The documents from Sl. No. 1 to 5 are compulsory for all and Sl.No. 6 to 16 are for the cases wherever applicable.
